State Departments steps to print and disseminate</li> </ul> <p>Mary Peters gave an overview of some of the current initiatives related to serving young children with disabilities in natural and least restrictive environments. Glenna Carter passed out and shared samples of existing materials that are at CCIC or CESAs related to public awareness, child find, and/or collaborations. Mary asked the committee to consider what materials need review, revision, or elimination. Further discussion included:</p> <ul style="list-style-type: none"> <li>a. Connection to existing screening efforts – should we look at this material in relationship to screening</li> <li>b. Status of Think Big Start Small that is the brand on many of the materials – do we want to continue the effort and reframe it under TBSS, do we want to think about co-branding with WECCP,</li> </ul>	<p>Add someone from child care to the screening committee. Invite people who know history of various publications to the meeting.</p> <p>Have the screening committee review the screening/child find materials and make recommendations.</p> <p>Ask the various screening committees to combine/align efforts.</p> <p>Interest in continuing the TBSS. More information is needed. Kath, Glenna, and Jill will provide an overview to the Action Team.</p>
